(2) The decision or order of the Government on all the matters shall be final."

11. *Amendment of clause 12.*— In clause 12 of the principal Scheme, for the expression "Secretary of the Legal Services Authority of the State of Goa", wherever it occurs, the words "District Collector" shall be substituted.

Read: (i) Notification No. DMG/MAJ/MAP/SCHEME/01 dated 7-3-2013 published in the Official Gazette (Extraordinary) Series I No. 49 dated 11th March, 2013 notifying the "Umbrella Scheme" viz "Mining Affected/Impacted Relief Scheme, 2013.

(ii) Notification No. DMG/MAJ/MAP/SCHEME/02 dated 7-3-2013 published in the Official Gazette (Extraordinary) Series I of 49 dated 11th March, 2013 notifying the "Scheme for providing financial relief to the truck (tipper) owners engaged in mining operations in mining affected area".

(iii) Notification No. DMG/MAJ/MAP/SCHEME/03 dated 7th March, 2013 published in the Official Gazette (Extraordinary) Series I No. 49 dated 11th March, 2013, notifying the "Scheme to provide financial relief to the people residing in Mining Affected Areas, who have lost their employment due to closure of Mining Industry".

In exercise of the powers conferred under clause (5) of the Umbrella Scheme [read at (i) above] empowering it so to do, the Government of Goa is pleased to amend the schemes read at (i), (ii) and (iii) above, so as to remove certain difficulties arising out of the implementation of the scheme (s) viz:

(1) Amendment to clause 3(b)(iii) of Notification read at (i) above.

The following is added after clause 3(b)(iii) or

3(b)(iii) as a proof of continuous residence applicant can submit any other document issued by the Goa State Government Department like residence Certificate, school leaving certificate, driving license showing that the applicant was residing in the area prior to 2009, for those applicant who were not eligible to get their name enrolled in the Electoral Roll.

(2) The amendment to clause 2(e) of notification read at (iii) above, the clause 2(e) is to be read as "The applicant/beneficiaries whose service has been terminated from 31-05-2012 shall be eligible under this scheme."
